6.19 ANNUAL REPORTS

Councillor Wild's Report had been circulated previously. Police and Crime Commissioner can buy Smartwater for every household in the Parish. Small bottle contains DNA and this is exclusive to house delivered to. If any property is stolen and found it can be screened by Ultra Violet and this tells Police if this item is property of household.

Paris Council has to buy it then Police will hand out to households. Register DNA code for each house. Cost is £10 per household but Parish Council get a 25% discount.

Ram Aston is the person to contact. Households can then put up Smartwater signs in

Shropshire Council going down to 2 Planning Committees from 3. Sometimes Planning Committees have 3 or 4 applications on the agenda. A lot of people involved. Will now just have North and South, making it more efficient.

Big problem in Shropshire amount of looked after children – gone from 280 in recent years to 400 now. Another issue is Cuckooing – this is about inviting people into families then getting children to drug run.

Police Report: Clerk tried to contact PC David Walton to invite him to the meeting but his email bounced back. Councilor Wild said he has left the area. Clerk mentioned email which has been sent regarding two Rural Crime Prevention evenings where police and agencies they work with will talk to the community. 25th June Shipton Village Hall and 27th June starting at 7.30pm. It was decided that as many of Parish Council at attend as possible as they will be discussing Smartwater.
