Proposal: Proposed replacement Toilet and Shower Block in support of existing caravan park previously approved (16/02140/FUL)

Still a few issues but Mandy Starr keeps a regular eye on it. Concerned about the size of the toilet and shower block. Councillors thought that 71 sqm toilet block a bit on the excessive size however it was agreed not to object to this application.

19.37 Parish Matters

- (i) Clerk has emailed National Trust twice regarding the fence going up Hughley Bank and showed the meeting their response. It was decided not to pursue the matter.
- (ii) Clerk contacted SWS regarding installation of broadband in Church Preen Village Hall. They said the installation costs could be met by Better Broadband by way of a voucher and SWS would give the village hall 10mb a month free of charge. This installation took place on Tuesday 5th November. Clerk asked if Councillor Morris could make sure the broadband was working before confirming with Better Broadband.
- (iii) SmartWater: Guest Tim Williams from West Mercia Police answered questions raised by Parish Councillors regarding having SmartWater in the three parishes. The SmartWater team was set up by Ram Aston and consists of an Admin Assistant, another young lady and Tim. Explained how they work with Parish Councils, the pros and cons of SmartWater and how he works with Parish Council from start to finish. This is about deterring crime and they have had some good results. Every bottle is unique and this is how it is identified; enough for 50 applications in a bottle. Dab or mark it on any property i.e Quad bikes, tools etc. This is naked to the human eye, dry to touch and waterproof so can put it on anything except shiny surfaces. Shines up green. Jewellery needs to be marked inside hallmark.
Costs: Kits purchased for 8.99 instead of £25 75% funded by PCC and 25% by Police. Signs will be put up on outskirts of Parish. A3 size with village name on, 3 villages and they would work out entrances to villages and put signs on them. Smaller ones on traffic signs, directional signs, can't put them on telegraph poles. Criminals recognise SmartWater logos. Parishioners will need to put stickers in windows. There is also a spray index system which is used in businesses and sprays a fine fluorescent mist. Stays on skin for 6-8 weeks
The Police are also engaging with secondhand dealers, pawn shops, those who don't are red flagged. Hopefully help to stop crimes being committed. Looking at eBay also. Criminals will go for easy option. Farm Packs – looking at doing similar scheme with farms. A lot more solution required and signage. Farmers will benefit in the long run.
There is no money in the CIL fund only pay CIL if more than three houses built. SmartWater would have to be paid for out of the Precept. It was decided to go ahead and order SmartWater for 100% of parishioners in all three parishes. Mr Williams will email information to Clerk along with application form. Proposed by Councillor Willberry and seconded by Councillor Roberts.
