- 19.14 Welcome by Chairman: The Chairman welcomed all Parish Councillors and members of the public to the meeting and went through fire procedures.
- 19.15 No apologies were received.
- 19.16 Declarations of Pecuniary and Personal Interest: There were none declared.
- 19.17 Public Session members of the public are invited to speak: Edie Jones invited members to the Harvest Supper on 5th October 2019.
- 19.18 To confirm and accept Minutes from Parish Council meeting 14th May and AGM Minutes 14th May 2019. It was agreed that these were a true and accurate record of the meeting by all members present.
- 19.19 Matters Arising from Minutes: Smartwater if they find someone with your property they can prosecute them. The Police do find quite a lot but because of GDPR they are not allowed to divulge personal information. If you have Smartwater in the area crime does come down and you get signage. When everyone has stickers in their window potential thieves will see that property has Smartwater. £25 if bought off internet but if Parish Council buy more than 80% of the number in the Parishes can buy them for £6.60 + VAT but the VAT can be claimed back. Over 100 people at the meeting and seemed interested. Wenlock refused to do it because they can't afford it. Some people already have it but if had for more than 5 years it should be renewed. They also have to pay an annual subscription but if PC bought them for Parish, they wouldn't pay this. Need to find out how may households are in the 3 parishes. A lot of the vehicles now have trackers which helps find vehicles. If Smartwater purchased they would be delivered by Parish Councillors around the parishes. Signage itself is £80 and Police put them up.

19.20 Clerk's Report:
