21-22.62 Shropshire Councillor's Report

Highest rates of COVID since pandemic began in RSH.

Assisting with accommodating Ukraine refugees – Council will signpost people who are interested in taking in refugees. Council will have to find schools, benefits. People who have holiday let accommodation to use for refugees will need to pay business rates – Council may be able to help with this.

Queen's Green Canopy – Parishes can be given a tree by Shropshire Council (ask Dianne) and will then get a certificate and plaque for tree. Clerk asked to enquire about one tree per parish for Kenley, Hughley and Church Preen.
